About The Camp!

For 8 to 16 years of age. Maximum of 30 children.

Camp runs Monday, March 16, 2010 to Friday, March 20, beginning each morning at 8:30 am and ending each afternoon at 4:00 pm. Before and after care will not be provided.

Students should bring a sweater or sweatshirt to keep muscles warm during dance breaks.

Students will take snack breaks and a one-hour lunch break to rest, relax and socialize. As dance is hard work, we recommend that you provide your child with wholesome snacks, lunches and fluids. A refrigerator is available for storage of lunches and snacks.

On the last afternoon students will showcase the work they have done all week. We encourage family and friends to attend this show at no cost to support your child's achievements. Lunch will be provided for the campers on that day.

All sessions will be held at Woodroffe United Church, 207 Woodroffe Avenue. Staff cell phone numbers will be distributed the first day of camp.

About the Fees!

\$200

A \$20.00 administration fee is included in each camp fee. This fee is non-refundable unless Suzart Productions Inc cancels the camp session due to lack of students. At which time the entire payment amount will be refunded.

A deposit of \$100.00 must be paid at the time of registration. The remaining fees must be paid by post-dated cheque at the time of registration.

Suzart is not equipped to take credit card or direct debit payments. Payment can be made by cash or cheque.
